On May 15, 2014, the Cora Stickney Harper Chapter, DAR celebrated their 100th anniversary. The Chapter was organized in 1914 thanks in great part to Cora Stickney Harper, a Miami chapter member who worked tirelessly to attain the necessary number of verified descendants of American Revolutionary ancestors, who signed the Chapter register on June 14, 1914. At her death, the Chapter was renamed in her honor.

The St. Lucie River Chapter, SAR recently started a recruiting drive at the Ft. Pierce Farmer's Market, setting up a tent to recruit new members, and in the course of events, received inquiries about the DAR as well. It was thought that it would be a good idea for the local DAR chapter, the Cora Stickney Harper Chapter, to join in sharing the space in the future. This interaction culminated in a request for the St. Lucie River Chapter, SAR to provide a color guard for the 100th anniversary ceremony held at Pelican Yacht Club in Ft. Pierce, Florida.

The Continental Navy

The United States Navy in its earliest form began with a resolution passed by the Second Continental Congress on October 13th, 1775 authorizing the purchase of two vessels to be armed for a cruise against British merchant ships. On October 30th, Congress authorized two more ships for the purpose. None of the ships were to be new construction. Instead, they were to be purchased merchant vessels refitted for military use. Units were purchased and laborers set about strengthening the ships, making provision for the gun batteries and gun ports to be installed, etc. Thus the first ship to be commissioned was not the first ship authorized, but the first ship to finish conversion, the *Alfred*. Originally the *Black Prince*, a merchantman out of Philadelphia under the command of John Barry, she was purchased on November 4, 1775 under the October 30th authorization, refitted, and placed in commission on December 3, 1775.

Congress struggled with the idea of a navy, but the pressing need to operate against British ships forwarding arms and provisions spurred Congress to action. The Continental Navy was not envisioned to contest control of the high seas with the Royal Navy; resources simply were not available for such a task. Funding remained a constant issue throughout the war. The Continental Congress built up a cruiser navy of smaller ships, operating independently or in pairs, rarely risking engagement with British men-of-war. Continental Navy ships could range far and wide to execute the mission, with mixed results.

Additional measures had been in use for some time. Privateers operating under 1,697 Letters of Marque issued by Congress made prizes of captured British ships, and according to rules and customs of prize law, brought the ships and cargo before admiralty courts for condemnation and sale, the proceeds to be divided between the privateer ship's owner and its crew. Colonies also contracted for vessels

of their own service and protection.

It was not until December 13, 1775 that Congress passed a resolution authorizing the building of thirteen new frigates, five of 32 guns, five of 28 guns, and three of 24 guns. Only eight of these frigates ever made it to sea, however, the others either destroyed by British forces or burned by the Americans to prevent capture. Their effectiveness was limited, and all were captured, lost in action, or sunk by 1781.

The Franco-American alliance of 1778 brought the cooperation of the powerful French Navy. French ports were opened to Continental ships. American agents in France negotiated the loan of the merchantman *Duc de Durae*, renamed *Bonhomme Richard* by John Paul Jones, for use against the British. Jones, with a squadron including the American frigate *Alliance* and three French ships, the *Pallas*, *Vengeance*, and *Cerf*, sailed clockwise around the British Isles, taking 16 merchant vessels as prizes. In what may be the most notable engagement of the war, Jones' squadron confronted the British 44 gun frigate *HMS Serapis* and the 22 gun ship *Countess of Scarborough*. *Bonhomme Richard* and *Serapis* closed quarters and were lashed together as both ships sustained heavy damage. Hand to hand grappling ensued. The guns of the *Alliance* were brought to bear, forcing the *Serapis* to strike her colors. The French frigate *Pallas* also captured the *Countess of Scarborough*. Jones transferred his flag to *Serapis* as the damaged *Bonhomme Richard* sank two days later, and guided the *Serapis* to Holland for repairs. The event was an embarrassing defeat for the British Navy in her home waters, gaining Jones international notoriety.

Ships of the French Navy sent to the West Indies were now available to cooperate with the Continental Army during the Caribbean hurricane season from July through November. The September 1781 French victory in the Battle of the Virginia Capes against the Royal Navy gave the

French fleet control of the Chesapeake Bay, and allowed American and French forces to besiege British forces under Cornwallis and to compel their surrender, effectively winning the Revolutionary War.

The *America*, a 74 gun ship of the line launched in 1782, the only one built for service in the Continental Navy, was offered as a gift to France for the loss of the French ship of the line *Magnifique*. The gift symbolized the nation's appreciation for the service and sacrifice of the French during the American Revolution. Within three years, the *America* was inspected and found to be dry rotted beyond economical repair, probably due to the use of green timber in her construction, being all that was available. She was scrapped and later replaced by a larger *America*.

Of the approximately 65 vessels that served the Continental Navy during the Revolutionary War, relatively few survived. Two years after the end of the war, Congress, in need of funds, sold off the last ship. The frigate *Alliance*, the last American ship to fire a shot in the American Revolution, was also the last ship in the Continental Navy. She was auctioned off in Philadelphia on August 1, 1785 for \$26,000.
