## **Old Fort Park Rededication**

The St. Lucie River Chapter, SAR, supported the Cora Stickney Harper Chapter, DAR Rededication Ceremony at the Old Fort Park in Fort Pierce on October 15th. A Color Guard and additional support was provided. The ceremony was under the leadership of DAR Regent Karon Drew. Fort Pierce Mayor Linda Hudson, a DAR member, spoke briefly. A history of the park



was given by Honorary Regent Joanne Humphries. Many DAR chapter members were in attendance as well as Compatriots Jack Irvin, Jay Wise, John Shepperd, Chuck Berger, Carl Wade, and Joe Regan. Compatriot Regan played Call to Colors and Retreat on Compatriot Wade's bugle.

The Old Fort Park has both national and local significance as one of the early forts built to support the Seminole battles in the 1820s. Local history consists of an Indian burial mound on the site and an Historical Marker installed in 1925, later stolen and replaced by Boy Scouts. The original marker was later found and reinstalled. The Fort Pierce Parks Senior Planner of the Planning Department discussed plans for future improvements; this was followed by Matthew Samuel, Vice President of the Fort Pierce Lions Club, on their support for future improvements. Many local residents were in attendance who enjoyed the afternoon's activities. Our Thanks to the Cora Stickney Harper DAR chapter officers for inviting us to participate in this local civic activity.
